The Post Superannuation Group Health Insurance Policies have been renewed for a period of one year from 1.2.22 to 31.1.23, with the following Insurance Coverages:

Sl. No.	Scheme for	Coverage (Rs./p.a)
i	Employees (Executives & Workmen) retired before 1.1.07	Inpatient - Rs. 3 Lakhs & OPD - Rs. 10,000/- , jointly in respect of the retired employee & spouse, on a floater basis.
ii	Executives retired/ retiring etc. after 1.1.07	Inpatient - Rs.8 Lakhs & OPD - Rs. 20,000/- , jointly in respect of the retired employee & spouse, on a floater basis.
iii	Workmen retired/ retiring etc. after 1.1.07	Inpatient - Rs.4 Lakhs & OPD - Rs. 20,000/- , jointly in respect of the retired employee & spouse, on a floater basis.

2. Insurance Policies for the current year have been taken from M/s. The New India Assurance Company Ltd. The Third Party Administrator (TPA) continues to be M/s. Medi Assist Insurance TPA Private Ltd. The Office Address of the TPA is M/s. Medi Assist Insurance TPA Private Ltd., Tower D, 4th Floor, IBC Knowledge Park, 4/1 Bannerghatta Road, Bangalore- 560029.

3. Existing Members of the Schemes will continue to use the Insurance Cards already issued to them with the same MAID No(s).

4. Ex-Employees / Executives / Workmen who retired in the past and were eligible to join the Schemes as at para-1 above, but could not enroll earlier, are permitted to enroll into the Schemes, w.e.f 1.2.22. A Window Period of 2 months upto 31.3.22 will only be available to them to enroll into the Schemes.

5. Considering the fact that benefits under the renewed Schemes are available from 1.2.22, eligible beneficiaries as at para-4 who have submitted Applications for enrollment into the Schemes can avail facilities w.e.f 1.2.22, pending receipt of the Insurance Cards by them. Reimbursement of Expenditure can be claimed by them, as provided in the Schemes, on receipt of the Insurance Cards.

6. Divisions/Offices will receive the Insurance Cards & Booklets in respect of new enrollments as at para-4, from M/s. Medi Assist Insurance TPA Private Ltd.

7. Procedure for enrollment of eligible Executives & Workmen who retire etc. from February 2022 onwards, issuance of Insurance Cards to them etc., would continue to be the same as in the past.
