## Reservation policy for PGDM programmes at HMA

The policy to be followed by the HAL Management Academy (HMA) for reservation in admission to its Post Graduate Diploma in Management (PGDM), programme is in accordance with the Karnataka Social Welfare Secretariat rules 2002.

HMA has been accorded approval for 120 seats in PGDM in Aviation Management (15 month Executive Programme), 60 seats each in PGDM (2 years programmes with specialisation in Production Management and Aviation Management). In Govt. Order Dated: 17-09-94 Govt. has formulated reservation policy for Schedule Castes and Scheduled Tribes and other Backward Classes for admission to professional courses:

Hence, the category of EWS has been introduced in the reservation policy.
